

Schedule of fines and bond for appearance which shall be imposed for the violation of the following ordinances, upon voluntary entry of appearance and upon a plea of Guilty or No Contest (K.S.A. 12-4305)

On or after December 12, 2006 sixty dollars shall be assessed on each municipal court case in which there is a finding or plea of Guilty, a plea of No Contest, forfeiture of bond, or a diversion.

If more than one complaint is filed against on person arising out of the incident, all of those complaints shall be considered as one case for the purpose of this order, and only sixty dollars (\$60.00) shall be assessed.
