Policy:

All Food Trucks should have a Food Truck Permit

\$15 for being in the City one time per year.

\$25 for being in the City two or more times per year.

Note: if later decide to go with multiple event/year permit, you'd just owe an additional \$10.

Can be applied for at any time during the year and does not limit where Food Truck can be located as long as the Vendor has permission from the Property Owner and the Food Truck is legally parked.

#### Exceptions:

These provisions shall not apply to the following activities:

- 1. The sale of farm or garden products or fruits grown by the seller or his or her employer or recognized Farmers Market
- 2. Individuals providing catering services to a private event and not open for the sale of food and/or beverages to the general public
- 3. Auctions
- 4. Garage Sales at private residences
- 5. Lemonade Stands
- 6. Brick and Mortar Restaurants already operating as a business within a City of Overbrook, KS address

#### Penalty:

First Offense: We let Vendor know they need a permit and give them the opportunity to fill out the paperwork.

Second Offense: Ticket issued \$15 Fine plus \$75 Court Cost (we would give them a permit once the fee is paid).
