very well. No concerns about all expenses and funds looked good. Bank recs are done timely and accurately. Overall looks great. Friends of library book sale is July 24-25, 2025. Evaluation increase looks the same, the same number as last year. Becky is looking into it. Library is supposed to get Wi-Fi soon. Air conditioners are fixed, and leaks were caulked. E3 Santa fe trail days-A request was presented to close the parade route starting at 2:00 PM until the end of the parade. The proposed route includes Santa Fe Street (from the end of the parade) to Market Street, Santa Fe Trail to Maple Street, and continuing to the alley going east toward East Street. Jon noted the importance of communicating with local businesses to ensure the closure will not interfere with operations. The Fair Board is expected to give final approval at their Thursday meeting and is currently supportive of the plan. Jon motions to approve proposal for street closure Cheryl, Matt Passed (5-0) F. Public Comment No comment from public G.1. Maintenance Action Items It was noted that many sewer lines run through alleyways, where utilities are also located, and there is a need to clean up these areas. An issue was reported in the alley between Maple and Oak Streets. A section of clay sewer pipe had previously been replaced, but the line now requires jet rodding, with further action anticipated. Additionally, a significant sewer issue occurred in the same area approximately four years ago, extending to the main line. Tree roots were a major factor at that time. It was recommended that this area be jetted and inspected with a camera, Danny recommends we do this sooner rather than later. An ongoing water issue near Highway 56 was discussed. Rural Water District #5 has assisted in the investigation, including checking nearby meters. It was confirmed that no active water supply leaks were found within approximately a half-block radius.

G. 2. OPR Action Items:	Further investigation is needed, including potential video inspection or dye testing to determine the source of the issue.  Dollar general sewer goes straight to manhole- needs mayors specialties need to get concrete out of manhole to fix. Large transfers in May and June, as well as two transfers each in June and July, caused temporary variances but will not occur next month.
